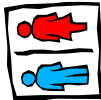

Picnic Reservation

Peck Park picnic areas can be reserved with a permit. Areas not reserved, can be used on a first come first serve basis.

- Area #1 15 Tables \$145

(Does not include 4 tables east of side walk)

- Area #2 8 Tables \$120

- Area #3 9 Tables \$120

- Area#4 18 Tables \$195

- No Summerland side or open area permits will be issued.

- No Amplified Sound.

- No Alcohol.

Jumper/Moon bounce permits

- \$20 Permit Fee

- Picnic permit required.

No exceptions. (no jumper permit will be issued without a designated picnic area permit)

- Jumper company must be on the City of L.A. approved vendor list.

- No waterslides or 3-in-1 jumpers allowed. Basic jumper only.
